FUNDING CONDITIONS

(Submitted to the SBA as part of the Proposed Budget)

I. GENERAL FUNDING CONDITIONS ON CONFERENCE ALLOCATIONS

- a. SBA funds allocated for conference expenses must be distributed equally among at minimum 4 student attendees unless otherwise specified by the SBA Budget Committee.

II. PILG FELLOWSHIP FUNDING CONDITIONS (AGREED TO BY PILG)

- a. Any single PILG/SBA funded fellowship recipient will receive a maximum of \$2,000, contingent on that student securing an additional \$2,000 of outside funding from an organization or party other than the UConn Law Foundation or any other existing source of PILG funding.
 - i. Proof of outside funding must be provided before SBA funds are transferred pursuant to that student's fellowship (e.g. statement on letterhead)
- b. Any single PILG/SBA funded fellowship recipient earning summer income in excess of \$4,000 will deduct excess income from the SBA funded portion of the fellowship, and return that amount to PILG for redistribution to new PILG recipients.
 - i. Proof must be submitted from employer describing compensation(e.g. statement on letterhead expressing amount, or if none, the absence of compensation)
- c. By the first day of the second semester (Spring 2009), a judging panel with alternates, responsible for selecting fellows, must be assembled and publicly announced to the school community.
- d. A formal fellow selection system must be drafted and submitted to the SBA by the first day of the second semester (Spring 2009). This information must be publicly available.
- e. Any candidate pursuing a PILG fellowship must solicit at least ten businesses and perform satisfactorily (as judged by a PILG Team Leader) in support of the PILG Auction in order to be eligible for a fellowship.

- f. Any PILG fellowship recipient must participate in the PILG Auction as a Team Leader or Auction Chair the year following receipt of their fellowship.

III. CLS FUNDING CONDITIONS

- a. Allocation for rental van only, limited to \$370, and spend on no fewer than four students' travel costs.
